ALL ANIMALS ENTERING THE CLINIC MUST BE CURRENT ON VACCINES & FREE OF EXTERNAL PARASITES (fleas, ticks, etc.) OR THEY WILL BE TREATED AT THE OWNERS EXPENSE. If your pet does not get it's vaccines at our clinic, you will be required to provide proof of vaccines (given by a licensed veterinarian) at the time of boarding, to include DHPP, Rabies and Bordetella for dogs, and FVRCP and Rabies for cats.

If your pet has mats or excessive undercoat (not able to pass a comb through coat) it will not be able to be maintained with normal care and will require chargeable grooming during its stay.

Take advantage of a bath or a groom the same day of your pet's release.

- If your pet has mats or snarls, it will be dematted at the beginning of its boarding stay and groomed on the day of release.

Please call before picking up to verify your pet is ready.

- Yes, I give permission for my pet to be GROOMED during its stay. A groom includes trimming, ear cleaning and a nail trim.
